

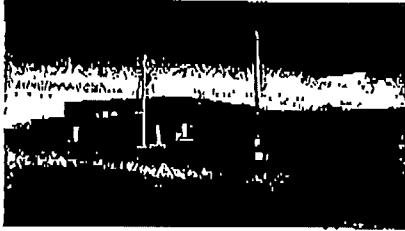
The Tate Topa Tribal School Board approved to dissolve the football cooperative at the May 23, 2012 school board meeting.
