Dear Mr. Bubach:

Please consider this letter has an official request from the Wing Public School District to be placed in Region VII for Fine Art Activities. At their April School Board meeting the Wing School Board approved a motion to move from Region V back to Region VII as soon as possible.

Our experience this year with Large Group Music which was in Cooperstown 123 miles from Wing, and with Region Speech in Finley 141 miles from Wing have predicated this decision. The distance between our region sites is difficult for our school, especially when these are the only activities which we have in common with the schools in Region V. This year for example we were forced to miss Large Group Music because of the change in our district basketball schedule.
